MULTIMEDIA AGREEMENT

This agreement for Services Rendered (the "Agreement"), effective on the following date: _____, is by and between Hot Spots in California, (hereinafter the "Provider"), and _____ (hereinafter the "Client").

1. PURPOSE

1.1 Promotional Multimedia Website. The objective of the Provider is to obtain respectable forms of promotional material from the Client, to then be placed onto the Provider's website in the correct category and county. Promotional material can include, but is not limited to: obtaining text, photos, slideshows, video, links, and any other helpful and descriptive entity, (hereinafter called "Multimedia").

1.2 Employment of Multimedia. Provider will make a "virtual tour," utilizing the Multimedia to create a video or slideshow video of the Client's place of business, (depending on the package chosen by the Client). Client is aware that changes will be made to the Client's presented or obtained Multimedia so that it corresponds with the traditional format of the Provider's website. The Client **MUST** own the rights to any Multimedia that is given to, or obtained by the Provider, and it must be **royalty free**.

1.3 Services. Results of sales and marketing are not guaranteed or implied other than that the Provider will make every reasonable effort to assure that the Client's multimedia listing is correct in content and function. It is the Client's sole responsibility to update the Provider of any company changes.

2. TERMS OF SERVICE

2.1 Linking. Once the Provider has added the Client's Multimedia listing to their website, the Client will be notified by phone, email or mail. After notification the Client will have up to 30 days to add a link on their website pointing to the Provider's home page; or add a link to their Multimedia listing on the Provider's website. Failure to comply could result in possible removal from the Provider's website or an increase in price.

3. PAYMENTS AND INVOICING

3.1 Payment Due. Client will be invoiced a low yearly fee to stay on the Provider's website with premium placement. Failure to pay can result in lower non-premium placement on the Provider's website and/or removal from the Provider's website.
